ORDINANCE NO. SCC 2009-02

AN ORDINANCE OF THE BOARD OF SUPERVISORS OF THE COUNTY OF SHASTA AMENDING CHAPTER 13.08 OF THE SHASTA COUNTY CODE REGARDING COUNTY LIBRARY REGULATIONS

The Board of Supervisors of the County of Shasta ordains as follows:

Section 1.

CHAPTER 13.08 of the Shasta County Code is amended in its entirety to read as follows:

Chapter 13.08
COUNTY LIBRARIES

13.08.010 County Library Regulations.

- A. It is unlawful for any person to engage in any of the following activities:
 - 1. Deface, cut, mar, or otherwise damage any county library structure, furniture, equipment, or materials.
 - 2. Damage in any way the grounds and facilities around any county library.
 - 3. Give other than his or her lawful name, address, and telephone number for the purpose of using any county library or checking out or receiving any county library materials or equipment, or when such information is requested of him or her by county library staff.
 - 4. Engage in loud talking, shouting, fighting, horseplay, or any other behavior which interferes with the legitimate use of a county library or the duties of any county library staff.
 - 5. Loiter within or upon the premises of any county library for the purpose of engaging in or soliciting any unlawful act.
 - 6. Use any county library facility or the grounds thereof for the purpose of sleeping, bathing, shaving, or washing clothes.
 - 7. Operate radios, televisions, tape or disc players, MP3 players, or similar sound-producing devices within any county library which can be heard by others in the county library.

- 8. Eat, drink, smoke, or use chewing tobacco in any public area of any county library, except in areas expressly authorized by the county library staff.
- 9. Seek or obtain signatures on any petition, conduct surveys or investigations, distribute printed materials, or solicit within any enclosed areas, or outside of enclosed areas on the premises of a county library except in accordance with reasonable time, place, and manner restrictions imposed by the county library staff.
- 10. Bicycle, unicycle, skateboard, skate (including rollerblades and the use of roller shoes), within any county library or on the grounds of any county library.
- 11. Remove, relocate, or reposition any county library equipment, facilities, tables, bookshelves, book stands, or other permanently placed equipment or facilities without permission of county library staff.
- 12. Remain in any county library after closing.
- 13. Enter any county library without wearing shoes or a shirt or removing shoes or shirt while inside the county library.
- 14. Bring an animal into a county library, with the exception of guide dogs, signal dogs, and service dogs as defined in section 54.1 of the California Civil Code.
- B. It is unlawful for any person to fail to obey a directive from library staff to cease and desist from violation of any regulation, statute, or ordinance applicable to the use of any county library or the grounds thereof.
- C. For the purposes of this section, the term "county library" means the Shasta County Branch Libraries located in the City of Anderson and the Town of Burney and any other Shasta County Branch Libraries that may be established by the County of Shasta. This section shall not apply to the Redding Municipal Library.
